## 1. Objective of MOU:

The objectives of the MOU are:

- a) To provide and enhance expression and sharing of knowledge amongst peer students from two different institutions.
- b) To provide exposure to the students about learning aid & infrastructure of institutions offering same Bachelors programme & specialization, affiliated with same University within the vicinity of Mumbai.
- c) To inculcate in students competitive skills for enhancing their academic interest.
- d) To promote research/continuing education activities between both the institutions.

## 2. About the Faculty and Students Exchange Programme:

The MOU is entered between the Department of Bachelor of Commerce with Accountancy & Finance (BAF) of Smt. P.N. Doshi Women's College, Ghatkopar, Mumbai- 86 AND Department of Bachelor of Commerce with Accountancy, Finance & Insurance (BCOM AFI) of Maniben Nanavati Women's College, Vile Parle (West), Mumbai-56, and hence,

- a) There will be faculty exchange from Department of each of the institutions.
- b) One faculty will conduct a lecture in the other Institution on a topic relevant to their study to develop academic interaction and to enhance teaching skills of the faculties.
- c) Fifteen students of second year will be recognized by respective institutions for the purpose of exchange. These advance learner students will get exposure of attending lectures in the other Institute.
- d) The above students will be participating in all the activities undertaken within the purview of the said programme and will be entitled for participating certificates. The activities so undertaken will help the students in developing their competency and personality.
- e) The activities to be conducted during the programme shall be decided mutually by the Coordinators of the said programme of both the Institutions.
- f) The Coordinators reserves the right for any change of activity by their mutual consent before or during the conduction of the programme.

## 3. Proposed Modes of Collaboration:

The Department of Bachelor of Commerce with Accountancy & Finance (BAF) of Smt. P.N. Doshi Women's College, Ghatkopar, Mumbai- 86 AND Department of Bachelor of Commerce with Accountancy, Finance & Insurance (BCOM AFI) of Maniben Nanavati Women's College, Vile Parle (West), Mumbai-56, proposes to collaborate through the following:

- a) Propagation of education and training in the areas of mutual interest.
- b) Co-operation and conduction of various activities with consent of faculty members.
- c) Any other appropriate mode of interaction agreed by and between the Departments of the two Institutions.

A schedule of activities and conduction will be drafted with the consent of the Coordinators of both the Institutions along with this MOU.

#### 4. Duration of the Programme & MOU:

The Faculty & Students Exchange Programme shall be conducted between the two Institutions including exchange of faculties as well as students, in all for the period of one week i.e. six working Days. The undersigned MOU will be valid for two the period of academic years i.e. 2019-2020 and 2020-2021.

#### 5. Terms & Conditions :

- a) The cost incurred for travel of faculties & Students during the *Faculty and Students Exchange Programme* to and fro- from each college shall be borne by both the institutions individually.
- b) The cost of infrastructural utility including use of classrooms, teaching aids, books, resources, internet, laptops, OHP'S, Projectors, etc. shall be borne by both the institutions individually.
- c) The expenses relating to the Visits, Certificates, Prize, Trophy's, Refreshments, Honorarium expenses for inviting Experts, Judges during the programme shall be borne by both the Institutions collectively and equally.
- d) The institutions reserve right to be indemnified for the expenses incurred specifically during the conduction of this programme collectively and equally.
- e) However, the institutions are free to arrange sponsors for part or whole of the programme.
- f) Both the Institutions agree to co-ordinate, co-operate in organizing activities, identifying and inviting the faculty members/ Experts/Judges and arranging for the visits.
- g) The MOU may be amended, renewed and terminated mutually by the institutions. In case of termination of the MOU before time, either institute shall reserve the right to terminate this MOU, by giving a written notice of not less than 30 days to the other institute.

#### 6. Confidentiality:

## 2. PROGRAMME BACKGROUND

The National University Students' Skill Development (NUSSD) Programme is a unique initiative on skill development designed and delivered by the Tata Institute of Social Sciences (TISS). The programme was initiated in 2013 in collaboration with Ministry of Youth Affairs and Sports, Government of India (GoI) and National Skill Development Agency (NSDA), GoI to enable graduating youth acquire employable skills while pursuing their graduation or post-graduation so that they are job-ready as and when they pass out from the colleges. 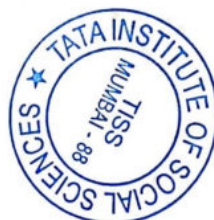

- NUSSD Courses are designed in a modular, interlinked and interactive manner: cumulatively building knowledge, skills, and competencies administered through classes and field work.
- The course credits are spread over the years (Second and Third) of graduation and the students are taught courses (lectures and tutorials) followed by Field work / Internship in appropriate work location.
- Field work / internship in urban / rural contexts in community and industrial set up are organized during holiday /vacation to gain hands-on practical experience.
- During the training, students will be introduced to the purpose of NUSSD programme and need for skill development through a series of interactive sessions at the university and its affiliated colleges.

(iii) Foundation skills for professional competencies

All students enrolled for NUSSD will gain competency in following areas -  
(Foundation Courses for professional competencies):

Certificate in Management and Soft Skills

2. Youth Leadership & People Skills

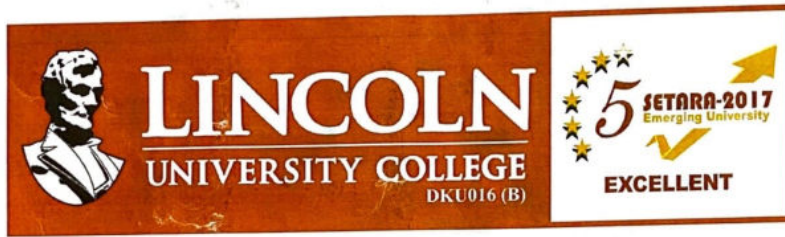

**MEMORANDUM OF UNDERSTANDING (MoU)**

This MoU is an agreement between the AGASTYA KAPOOR FOUNDATION, hereafter known as AKF, located at A-1004, Pluto CHSL, Suncity Complex, A. S. Road, Near Gandhinagar Flyover, Powai, Mumbai - 400076, Maharashtra, India and the SWAYAM Centre for Counselling under the aegis of Department of Psychology, MANIBEN NANAVATI WOMEN'S COLLEGE, hereafter addressed as MNWC located at Vallabhghai Road, Vile Parle West, Mumbai - 400056, Maharashtra, India. MNWC is an established educational institution with the mission statement of empowering women through access to higher education. AKF is an NGO.

centre for mental health support through various online and/or offline.

11. MNWC will not be responsible for any kind of financial liability except offering the premises and bearing electricity and infrastructure expenses.

This Agreement is entered on the 1<sup>st</sup> February 2022 to undertake counselling project for the mental health benefits of the students, teaching and non-teaching staff of MNWC, and the community outside it.

**Terms of Agreement:**

1. The SWAYAM Counselling Room on the 5th floor of the MNWC Premises is to be used for counselling. The premises will be available on working days between 10.00 AM to 4.00 PM.
2. Students and Peons of MNWC will receive FREE COUNSELLING SERVICES. Teaching and Administrative staff of MNWC can avail paid services as per the MNWC Management policy.
3. Counselling for students and peons will happen 2 days a week from 10.00 AM to 2.00 PM with prior appointment taken from the counsellor. If AKF wishes to extend it to more than 2 days a week, it will be discussed beforehand with the MNWC authorities and decided.
4. The students of the Post Graduate section of the Department of Psychology of MNWC will be given internship opportunities at the centre for the completion of stipulated hours.
5. The salary expenses of the appointed counsellor(s) will be totally and in full be borne and paid by AKF. The counsellors will be appointed by AKF and the salary of counsellors will be directly paid by AKF, and AKF will keep the salary slips in its custody. The terms and conditions for the counsellor's job profile will be described in his/her appointment letter released by AKF.
6. The Department of Psychology will manage the counselling cell and look into matters of counsellor recruitment, work hour planning, report generation, student support, in-house MA Psychology internship, psychological testing, workshop conduction for teaching and non-teaching staff, and any other mental health requirements that may arise through the counselling centre. The reports will be shared with AKF for purposes of audit. The counsellor will be expected to adhere to the institutional timings and regulations along with wearing the ID Card provided by the institution.
7. The centre will offer free (only to needy people) as well as paid services to people outside the college stakeholders in the hours other than that prescribed for MNWC students and peons. A fee of Rs. 700/- only (Rupees Seven Hundred only) per session for this year will be charged from the outsiders in which Rs Five Hundred will be paid to the counsellor and the remaining amount will be distributed between AKF and MNWC where AKF gets 60 percent and MNWC gets 40 percent of the amount.
8. Paid service for outside people should start at least after 6 months of commencement. It will give enough time for things to settle down and initial online publicity.
9. AKF has applied for the registration process with the concerned authorities and upon receiving their registration number and document will submit the photocopy of the same to MNWC.
10. AKF will look into the promotion of the counselling centre and the college as a centre for mental health support through various online and/or offline.
11. MNWC will not be responsible for any kind of financial liability except offering the premises and bearing electricity and infrastructure expenses.



12. This MOU will be operational for ONE YEAR from the date of commencement and can be withdrawn with a one-month notice from either of the parties.



The purpose of this MOU is to set forth certain understandings of the parties in relation to organize the YathaKatha International Fi'm and Literature Festival tentatively in the month of November every year. Wherein ManibenNanavati Women's College, Mumbai will be its main organizing partner and collaborate in organizing it in a suitable manner at its venue. However, any decision related to the organization of the festival will be discussed and taken by both the parties. There will be no financial liability on ManibenNanavati Women's College, but the College will promote the said festival on its entire media and help YathaKatha International Film and Literature Festival in its promotional events.

### **Duration**

This Memorandum shall remain valid for a period of three (3) years starting from 28<sup>th</sup> June, 2021 to 27<sup>th</sup> June 2024. On its expiration, it shall be automatically renewed by tacit agreement, for additional period of three years, each, unless notice to terminate is given in writing by one of the contracting parties six (6) month prior to the expiration of the relevant period.

### **Confidentiality**

The parties shall keep strictly confidential of any and all information, including but not limited to the information, which may be disclosed or confided between YathaKatha International Film and Literature Festival and MNW College during and after the organization of the festival.





From MNW College side Dr. Rajshree Trivedi and Dr. RavindraKatyayan will be coordinating. From YathaKatha International Film and Literature Festival side Ms. Charu Sharma will be coordinating.
