1	Assistant Professor in B. Com (Accountancy, Finance & Insurance) TYBAFI-1	1FT	1.Good academic record with at least 55% of the marks or equivalent grade where grading system is practiced at the Master's degree level in a relevant subject from an Indian University ,or an equivalent degree from an accredited foreign University.
2	Assistant Professor in B. Com (Accountancy & Finance) FYBAF-1 SYBAF-1	2FT	2.Besides fulfilling the above qualifications,the candidate should have cleared the National Eligibility Test (NET) conducted by the UGC,CSIR, or similar test accredited by the UGC like SLET/SET. 3. Holders of Ph.D. degree as on the date of Notification of these Regulations,alongwith those candidates who are awarded a Ph.D. degree through a process of admission , registration course work and external evaluation as laid down in the UGC (Minimum Standards and Procedures for award of M.Phil./Ph.D. Degree), Regulations,2009 and so adopted by the University, shall be exempted from NET/SLET/SET.
3	Assistant Professor in M. Com (Advanced Financial Management, Accounting and Auditing)	2FT	4. NET/SLET/SET shall also not be required for such Masters Programmes in discipline for which NET/SLET/SET is not conducted subject to the conditions stipulated in UGC Regulations in clause.3.0.0
5	Assistant Professor for B.Design - Fashion Design	2FT 4 CHB	M.Sc Textile and clothing + NET/SET (The course that has only Textiles and Clothing related subjects shall be considered for the appointment.Plus experience of fashion industry/fashion education in high repute institute or equivalent. OR M.Sc. Fashion Design/M.Design (No NET/SET is available) Minimum 5 years Teaching /Industry experience.(Test will be conducted) or equivalent. OR M.Design with Communication or Graphics for Fashion Communication (No NET/SET is available)

NOTE:-

- 1 A minimum of 55% marks (or an equivalent grade in a point-scale,whether the grading system is followed)at the Master's level shall be the essential qualification for direct recruitment of teachers and other equivalent cadres at any level.
- I A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)(Non-creamy Layer)/Differently-abled **(a)**Blindness and low vision;**(b)**Deaf and Hard of Hearing; **(c)**Locomotor disability including cerebral palsy,leprosy cured,dwarfism,acid-attack victims and muscular dystrophy;**(d)** Autism,intellectual disability,specific learning disability and mental illness;**(e)** Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment.The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible,based only on the qualifying marks without including any grace mark procedure.
- 2 A relaxation of 5% shall be provided,(from 55% to 50% of the marks) to the Ph.D Degree holders who have obtained their Master's Degree prior to 19 September,1991.
- 3 A relevant grade which is regarded as equivalent of 55% ,Wherever the grading system is followed by a recognized university,at the Master's level shall also be considered valid.
- 4 For the open posts candidates from backward classed as well as physically challenged persons can also apply.
- 5 The reservation for women and physically challenged persons shall be as per the Govt.of Maharashtra rules.
