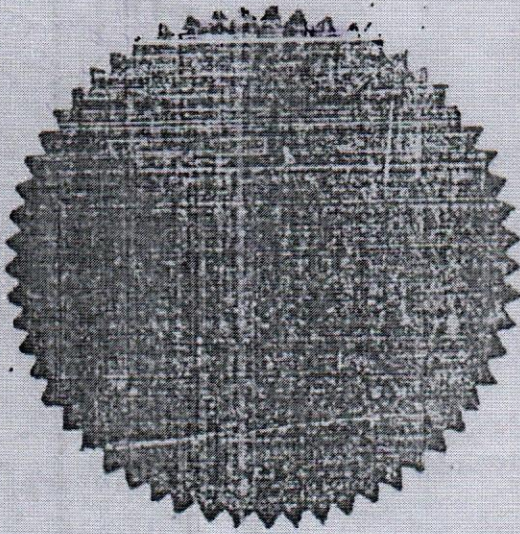
P.C. :- Rule.

In the capacity of a minority managed educational institution, your college can avail of the following relaxations in case of appointments of your teaching staff as per D.E's letter no. MIS 1987/41180-9A (BH) dated 1-1-90.

- (1) You shall have the freedom to appoint any qualified candidate, but it would be advisable for you to select teachers and other employees through Employment Exchange or open advertisement.
- (2) Teachers appointed by your college should possess requisite qualifications.

According to the amended Statute no.13 of the S.N.D.T. Women's University, Bombay, rules of constituting Selection Committee for selection of Principal/teachers shall be relaxed.

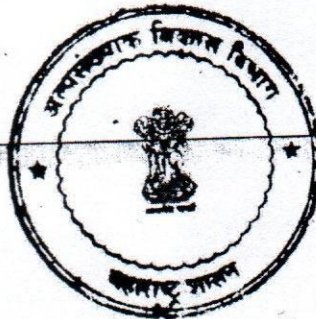
