MEMORANDUM OF UNDERSTANDING

This Memorandum of understanding ("MOU") is made on 35 June 22by and between:

Maniben Nanavati Women's College, Vile Parle, which expression unless repugnant to the context thereof, shall mean and include its successors and permitted assigns as the First Part.

AND

Institute of Indian Culture, Andheri East, Mumbai, (IIC), which expression unless repugnant to the context thereof, shall mean and include its successors and permitted assigns as the **Second Part**.

Maniben Nanavati Women's college and HC shall be referred to as "Parties" collectively and as "Party" individually wherever the context so requires.

Maniben Nanavati Women's College and IIC collectively have proposed a course titled

STAR - STUDENT AID FOR RESEARCH"

This course aims to empower undergraduate students of Maniben Nanavati Women's College, Vile-Parle, with knowledge and skills of qualitative research. The youth become critical thinkers, conscious and contributing citizens and some of them may also become leaders of their communities, thus enhancing the quality of life for themselves and their communities and cities.

The program design includes creating small groups of students, at Maniben Nanavati Women's College, who would be trained to do research on the themes/subjects related to their choice of topic.

IIC has represented to Maniben Nanavati Women's College that the following activities will be undertaken, inter alia, as part of the course: during the academic year 2021-2022

Training:

IIC would be responsible for conducting the following workshops throughout the year:

1 Community Based Research (CBR)

- a. What is research?
- b. Types of research
- c. Understanding COMMUNITY BASED RESEARCH

2 Literature Review

- Importance of reviewing literature
- b. How to conduct review
- c. Appropriate citation, annotation and bibliography

3 Analysis, Synthesis and Drawing Conclusions

This section will focus on what is analysis, importance of analysis and its relationship with the hypothesis, how to do the analysis and how to draw conclusions based upon the analysis. Importance of reading through the data carefully and culling out emerging themes, thematic analysis and writing interpretations will be explained and taught.

Report Writing and Presentation

Importance of writing good report, - structure, content, language, annotations etc will be covered under this section.
